



## **NOTICE OF INTENT TO ACT UPON A REGULATION**

### **Notice of Workshop and Hearing for the Adoption of Regulations**

#### **The Nevada State Board of Architecture, Interior Design and Residential Design LCB File No. T001-20**

The Nevada State Board of Architecture, Interior Design and Residential Design Board will hold a virtual **Public Workshop via Zoom** on Thursday, October 15, 2020 at 2:00 p.m.

The **Public Hearing** will be held on January 20, 2021 at 12:00 p.m. in the Gina Spaulding Boardroom located at 2080 E. Flamingo Road, Ste. 120, Las Vegas, Nevada 89119. This meeting may be held virtually via Zoom.

The purpose of the workshop and hearing is to receive comments from all interested persons regarding the adoption of regulations that pertain to Chapter 623 of the Nevada Administrative Code.

The following information is provided pursuant to the requirements of NRS 233B.0603:

- 1. The need for and purpose of the proposed regulations or amendments.**
  - a. Proposed regulation section of the NAC:** The purpose of the adoption of this regulation is to add an option for candidates who are enrolled in an Integrated Pathway to Architectural Licensing (IPAL) option from a NAAB-accredited program and allow them to take the Architect Registration Examination before obtaining their degree under Nevada Administrative Code (NAC) Chapter 623. Additional changes were housekeeping updates of obsolete information.
- 2. Either the terms of the substance of the regulations to be adopted, amended or repealed, or a description of the subjects and issues involved.**
  - a.** The intent of this regulation is to add an additional path for the highly motivated candidates and allow them to take the Architect Registration Examination (ARE) before graduation.
- 3. The estimated economic effect of this proposed regulation on the business that it is to regulate and on the public. These must be stated separately and, in each case, must include:**
  - a. Both adverse and beneficial effects; and**

There is no adverse effect of regulation T001-20. The beneficial effect of this regulation change is that it provides another option for aspiring architects who are enrolled in the IPAL option to complete their education and intern hours, and take the exams, in roughly half the time of the more traditional route. IPAL doesn't eliminate the requirements of licensure, but rather it offers students a way to fulfill some of those requirements while they're enrolled in National Architectural Accrediting Board-approved architecture programs.

**b. Both direct and indirect effects.**

The direct effect of T001-20 will be that applicants enrolled in the IPAL option can complete their education and intern hours and take the exams in almost half the time of the more traditional path. The indirect effect is that the applicants will have the opportunity to enter into the profession having more options and having more opportunity.

- 4. The estimated cost to the agency for enforcement of the proposed regulation.**

There is no cost to the agency.

5. **A description of and citation to any regulations of other state or local governmental agencies that the proposed regulation overlaps or duplicates and a statement explaining why the duplication or overlapping is necessary. The proposed regulation does not overlap or duplicate any regulation of other state or local governmental entities.

Flamingo Road, Suite 120, Las Vegas, Nevada 89119. **Written submissions must be received by the Board on or before Tuesday, January 19, 2021.** If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Board may proceed immediately to act upon any written submissions.

A copy of this notice and the regulations to be adopted will be on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notices and the regulation to be adopted will be available at the Nevada State Board of Architecture, Interior Design and Residential Design, 2080 E. Flamingo Road, Suite 120, Las Vegas, Nevada 89119 and in all counties in which an office of the Board is not maintained, at the main public library, for inspection and copying by members of the public during business hours. This notice and the text of the proposed regulation are also available in the State of Nevada Register of Administrative Regulations, which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653 and on the Internet at <http://www.leg.state.nv.us>. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary. This does not apply to a public body subject to the Open Meeting Law.

Upon adoption of any regulation, the Board, if requested to do so by an interested person, either before adoption or within 30 days thereafter, shall issue a concise statement of the principal reasons for an against its adoption or incorporate therein its reason for overruling the consideration urged against its adoption.
