For residential subdivisions where all dwellings are equipped throughout with an automatic sprinkler system installed in accordance with Section P2904, the fire separation distance for exterior walls not fire-resistance rated and for fire-resistance-rated projections shall be permitted to be reduced to 0 feet, and unlimited unprotected openings and penetrations shall be permitted, where the adjoining lot provides an open setback yard that is 6 feet or more in width on the opposite side of the property line.
- b. The fire-resistance rating shall be permitted to be reduced to 0 hours on the underside of the eave overhang if fireblocking is provided from the wall top plate to the underside of the roof sheathing.
- c. The fire-resistance rating shall be permitted to be reduced to 0 hours on the underside of the rake overhang where gable vent openings are not installed.



### Design no. L521

Unrestrained Assembly Rating — 1 Hr Finish Rating — 25 Min (See Items 5 and 5A), 20 Min (See Items 6H and 7A)

This design was evaluated using a load design method other than the Limit States Design Method (e.g., Working Stress Design Method). For jurisdictions employing the Limit States Design Method, such as Canada, a load restriction factor shall be used — See Gulde BXUV or BXUV7

1. Flooring System - The flooring system shall consist of one of the following:

#### System No. 1

Subflooring — Nom 23/32 in, thick wood structural panels installed perpendicular to trusses with end joints staggered. Plywood or panels secured to trusses with construction adhesive and No. 6d ringed shank nails, spaced 12 in, OC along each truss. Staples having equal or greater withdrawal and lateral resistance strength may be substituted for the 6d nails.

Vapor Barrier - (Optional) - Nom 0.030 in. thick commercial asphalt saturated felt.

Finish Floor — Min I by 4 in. T & G lumber installed perpendicular to trusses, or min 15/32 in. thick wood structural panels, min grade "Underlayment" or "Single-Floor". Face grain of plywood or strength axis of panel to be perpendicular to joists with joints staggered.

#### System No. 2

Subflooring — Nom 23/32 in. thick wood structural panels installed perpendicular to trusses with end joints staggered. Plywood or panels secured to trusses with construction adhesive and No. 6d ringed shank nails, spaced 12 in. OC along each truss. Staples having equal or greater withdrawal and lateral resistance strength may be substituted for the 6d nails.

Vapor Barrier - (Optional) - Nom 0.030 in. thick commercial asphalt saturated felt.

Finish Flooring\* - Floor Topping Mixture - Min 3/4 in. thickness of floor topping mixture having a minimum compressive strength of 1800 psi. Refer to manufacturer's instructions accompanying the material for specific mix design.

#### System No. 3 (For Use with Item 7A Only)

Finish Floor — Norm 23/32 in, thick wood structural panels installed perpendicular to trusses with end joints staggered. Plywood or panels secured to trusses with construction adhesive and 2-1/2 in, long nails, spaced 12 in. OC along each truss and 8 in. OC at the perimeter.

#### System No. 4

Structural Cement-Fiber Units\* — Nom 3/4 in. thick, with long edges tongue and grooved. Long dimension of panels to be perpendicular to wood trusses with end joints staggered a min of 2 ft and centered over the trusses. Panels secured to wood trusses with 1-5/8 in. long, No. 8, self- countersinking wood screw spaced a max of 32 in. OC in the field with a screw located 1 in. and 2 in. from each edge, and 8 in. OC on the perimeter with a screw located 2 in. from each edge, located 1/2 in. from the end edges of the panel.


#### System No. 5

Structural Cement-Fiber Units\* - Nom 3/4 in thick, with long edges tangue and grooved, Long dimension of page to be perpendicular to wood trusses with end joints staggered a min of 2 ft and centered over the trusses. Page secured to wood trusses

### **COORDINATION-OF-PLANS**

- Coordinate Architectural plans with Mechanical, Plumbing, and Electrical.
- Missing information or details on one or more plans.
- One of the most common plan review comments.. Multiple designers on one set of plans.
- Reduction in request for information.





# EMERGENCY·ESCAPE·AND• ••••WINDOW•OPENINGS

Per R310 Provide size and type to plans.

Minimum opening size of 5.7 square feet or 5 square feet if on the grade floor or below grade.



# **ATTIC-VENTILATION**


- 1. Provide attic ventilation calculations per IRC 806.2
- 2. Provide size of vents and the location on plans based on 1/150 or the exception of 1/300.
- 3. If using baffles, show detail with 1" air space.
- 4. Declare if attic is going to be vented or non-vented.



#### NOTE TO TRUSS MFG.

- 1. TRUSS MFG. SHALL SUBMIT SHOP DRAWINGS AND STRUCTURAL CALCULATIONS TO CONFIRM LAYOUT AND DIMENSIONS.
- 2. TRUSS MFG. MUST CROSS-REFERENCE STRUCTURAL SECTIONS TO VERIFY ALL TOP AND BOTTOM CHORD BEARING POINTS.
- UNLESS OTHERWISE NOTED, PROVIDE AN 18" OVERHAND AT EAVE LOCATIONS AND A 9" OVERHANG AT GABLE END LOCATIONS (U.N.O).
- 4. UNLESS SPECIFIED OTHERWISE, ALL ROOF TRUSSES SHALL HAVE TOP CHORDS OF AT LEAST 2X6 LUMBER (U.N.O.).
- CONDUCT FIELD VERIFICATION PRIOR TO STARTING CONSTRUCTION.
- 6. TRUSS MFG. SHALL COORDINATE WITH CONTRACTOR TO CONFIRM LOCATIONS OF MECHANICAL EQUIPMENT AND ATTIC STORAGE AREAS/SIZES BEFORE CONSTRUCTION BEGINS.
- 7. ENSURE AN UNOBSTRUCTED PASSAGEWAY TO THE ATTIC FURNACE WITH CONTINUOUS SOLID FLOORING AT LEAST 24" WIDE AND NO LONGER THAN 20', PER UMC SECTION 931.2 (CONFIRM MECHANICAL EQUIPMENT LOCATIONS). PROVIDE A LEVEL WORKING PLATFORM AT LEAST 30" WIDE IN FRONT OF THE SERVICE SIDE OF THE ATTIC APPLIANCE, PER UMC SECTION 904.11.4.

VENTILATION REQUIREMENTS: ENCLOSED ATTICS AND RAFTER SPACES, WHERE CEILINGS ARE ATTACHED DIRECTLY TO THE UNDERSIDE OF ROOF RAFTERS, MUST INCLUDE CROSS-VENTILATION FOR EACH SEPARATE SPACE USING VENT OPENINGS PROTECTED FROM RAIN OR SNOW, PER IRC SECTION R806. THE TOTAL NET FREE VENTILATION AREA SHALL BE AT LEAST 1/150 OF THE VENTILATED SPACE'S AREA, THIS CAN BE REDUCED TO 1/300 IF 50% TO 80% OF THE REQUIRED VENTILATION IS PROVIDED BY VENTS LOCATED IN THE UPPER PORTION OF THE SPACE, AT LEAST 3 FEET ABOVE EAVE OR CORNICE VENTS, WITH THE REMAINING VENTILATION PROVIDED BY EAVE OR CORNICE VENTS, PER IRC SECTION R806.2.

Provide correspondence letter on revisions and re-submittals. Clearly stating what has been corrected or revised. Identify with clouded area. Very common not be included or vague information.

Email or phone for clarification or questions.


